**Details :**

This project has a choice of three options as outlined below :

1. I have a list of sites, distributors, or potential customers to offer your product or service to.
2. I have a product(s) or service(s) that will be ready in about a week to offer to your list.
3. I see a product(s) or service(s) on your site that would be more profitable on our commercial site.
4. I have a product(s) or service(s) to offer to your list and also see a product(s) or service(s) on your site that would be more profitable on our commercial site.

Note : All products or services must be related in some way to our site, but not competing in any way. If you prefer we can sell any product or service of yours on our ebay account under the user ID ck—auctions (NOT ck-auctions.)

**Available Item(s) For Joint Venture Distribution :**

**The Profit :**

The split is 50/50 after paypal fees or if you choose for us to sell your product(s) or service(s) on our ebay account there will be listing and selling fees that will be deducted. We can choose to set up a contingency plan where we hold back 5% for charge backs. We will not be offering a money back guarantee because when you go into a store and purchase a book you do not get to return it if you don't like the ending.

**Payment :**

Payment will be completely accomplished within 24 hours. We will transfer 50% of profits to your paypal account after paypal fees have been deducted and require that you send a letter of financial receipt for tax purposes to us within 24 hours after payment shows completed in paypal. This also keeps it legal for tax purposes no matter what country we are in.

**Discount Offer :**

A list of 500 names has been known to generate at least \$1000 in sales for a 2-partner joint venture to split. My present item(s) will be listed for sale on ebay and ck-auctions.com between \$5.00 USD - \$15.00 USD. I want to put together an offering to list holders at a discount of 50% the sales price. **Distribution :**

Our customers will either be given a download address after they complete the paypal payment or receive an instant email with their purchase attached.

**Anti-spam :**

If it is your list then you must send out the emails and vice versa because we do not want to violate any spam laws. Caution: hotmail and yahoo will not allow you to send mass emails. They will block you or ban your account. Most other isps also have rigid rules for this as well. I suggest you use <http://www.getresponse.com> or <http://www.aweber.com> for a free auto responder account and trial email broadcasting membership. Your first promotion could pay for your fees to upgrade these accounts so that you can continually use as tools to support this other income stream.
